<b>APPLICATION FOR LICENSURE (BY EXAMINATION):</b> <ul style="list-style-type: none"><li>Licensed Professional Counselor [LPC] - (\$100 application fee + \$10 processing fee = \$110)</li><li>Associate Licensed Professional Counselor [APC] - (\$100 application fee + \$10 processing fee = \$110)</li><li>Master Social Worker [MSW] - (\$100 application fee + \$10 processing fee = \$110)</li><li>Clinical Social Worker [CSW] - (\$100 application fee + \$10 processing fee = \$110)</li><li>Marriage and Family Therapist [MFT] - (\$100 application fee + \$10 processing fee = \$110)</li><li>Associate Marriage and Family Therapist [AMFT] - (\$100 application fee + \$10 processing fee = \$110)</li></ul> <b>APPLICATION FEE WHERE EXAMINATION HAS BEEN TAKEN AND PASSED (BY EXAMINATION WAIVER):</b> <ul style="list-style-type: none"><li>This fee is for applicants who have passed the examination and will not re-take that examination (LPC and LAPC applicants, AMFT and MFT applicants LMSW). \$100 application fee + \$10 processing fee = \$110</li></ul> <b>APPLICATION FEE FOR LICENSURE BY ENDORSEMENT</b> - \$100 application fee + \$10 processing fee = \$110 <ul style="list-style-type: none"><li>This fee is for applicants who are licensed in other states who apply for Georgia licensure based upon that credential. <b>(NOT APPLICABLE TO SOCIAL WORKERS)</b></li></ul>	\$ 100.00 \$ 10.00 P.F. \$ 110.00
<b>REINSTATEMENT FEE</b> - Of a Lapsed Status License, Revoked Status License or for an Inactive Status License <b>of over 5 years</b> \$350 application for reinstatement fee + \$10 processing fee = <b>\$360</b>	\$ 350.00 \$ 10.00 P.F. \$360.00
<b>APPLICATION FOR INACTIVE STATUS FEE</b>	No Fee
<b>APPLICATION TO REACTIVATE AN INACTIVE STATUS LICENSE (of 5 years or less)</b> \$150 application fee + \$10 processing fee = \$160	\$ 150.00 \$ 10.00 P.F. \$160.00
<b>RENEWAL FEE:</b> ALL Licenses EXPIRE September 30 <sup>th</sup> of even numbered years. (Includes \$10 mail in renewal form processing fee)	\$ 100.00 \$10 P.F. \$110
<b>LATE RENEWAL FEE:</b> For renewal between October 1 <sup>st</sup> and December 31 <sup>st</sup> of even numbered years. (Includes \$10 mail in renewal form processing fee)	\$ 150.00 \$10 P.F. \$160.00
<b>DECORATIVE WALL CERTIFICATE FEE</b> <ul style="list-style-type: none"><li>As of July 1, 2001, there will be an additional charge for a decorative Wall Certificate that is suitable for framing. Submit a <b>separate</b> cashier's check or money order made payable to the "Georgia Composite Board of PC, SW and MFT."</li></ul>	\$ 50.00
<b>LICENSURE VERIFICATION FEE</b> \$35 fee + \$10 processing fee = \$45	\$ 35.00 \$10.00 PF \$45.00
<b>LICENSE POCKET CARD FEE</b> (submit a written request for verification and fee made payable to board via USPS mail) \$25 fee + \$10 processing fee = \$35	\$ 25.00 \$10.00 PF \$35.00
<b>NOTE:</b> <ul style="list-style-type: none"><li>Please make all checks or money orders payable to the "Georgia Composite Board of PC, SW and MFT",</li><li><b>APPLICATION FEES ARE NON-REFUNDABLE.</b></li><li>Checks returned for insufficient funds will be assessed a service charge pursuant to O.C.G.A. § 16-9-20.</li><li>All Examination fees are to be paid directly to the examination vendor, <u>not to the Board.</u></li><li>ALL requests for a name change (no charge) must be in writing to the Board and include a <b>COPY</b> of the legal document changing the name. There is a \$25 fee to request a new license pocket card reflecting the name change.</li></ul>
