APPLICATION FEE FOR LICENSURE BY ENDORSEMENT - \$100 application fee + \$10 processing fee = \$110) This fee is for applicants who are licensed in other states who apply for Georgia licensure based upon that credential. (NOT APPLICABLE TO SOCIAL WORKERS)	
REINSTATEMENT FEE - Of a Lapsed Status License, Revoked Status License or for an Inactive Status License of over 5 years \$350 application for reinstatement fee + \$10 processing fee = \$360	\$ 350.00 \$ 10.00 P.F. \$360.00

RENEWAL FEE: ALL Licenses EXPIRE September 30 th of even numbered years. (Includes \$10 mail in renewal form processing fee)	\$ 100.00 \$10 P.F. \$110
LATE RENEWAL FEE: For renewal between October 1st and October 31st of even numbered years. (Includes \$10 mail in renewal form processing fee)	\$ 150.00 <u>\$10 P.F.</u> \$160.00
