<p><u>RENEWAL FEE:</u> ALL Licenses EXPIRE September 30th of even numbered years. (Includes \$10 mail in renewal form processing fee)</p>	<p>\$ 100.00 <u>\$10 P.F.</u> \$110</p>

<p><u>LICENSE POCKET CARD FEE</u> (submit a written request for verification and fee made payable to board via USPS mail) \$25 fee + \$10 processing fee = \$35</p>	<p>\$ 25.00 <u>\$10.00 PF</u> \$35.00</p>
