PROVISIONAL PERMIT (A Six Month Permit/Non-Renewable) \$ 125.00

This permit is only available to applicants who are not residents of Georgia who have a current, unencumbered license in the state in which he or she resides. **DO NOT SUBMIT A PROVISIONAL APPLICATION IF YOU DO NOT MEET THESE CRITERIA.**

[Licenses in Inactive Status for five (5) years or more must file a Reinstatement Application]

#### LATE RENEWAL APPLICATION FEE

MASSAGE THERAPIST \$ 150.00  
(Fee received after November 1<sup>st</sup> of every EVEN numbered year to November 30<sup>th</sup> of every EVEN numbered year)

#### REINSTATEMENT FEES

MASSAGE THERAPIST \$ 200.00  
(Reinstatement is at the discretion of the Board)
